DEATH OF MR. E. COHEN.

The news of the death of Mr. Emanuel Cohen, which took place at his residence, Gover-street, North Adelaide, early on Sunday morning, will be received with regret by not a small section of the community. The deceased gentleman was well and widely known, and was greatly esteemed not only socially but by all who had business transactions with him. The late Mr. Cohen left London in the East-Indiaman Coromandel for Melbourne, on April 26, 1852, reaching the sister colony in August of the same year. Towards the end of the same month he came on to Adelaide. The break out of the Victorian diggings attracted Mr. Cohen as it did many others at that juncture, and being a youth 17 years of age fresh from London he left for the capital of the sister colony and then made for Forest Creek. Gold digging did not prove as successful as he could have wished, and he took a position in charge of stores at Forest Creek, Bunkers Creek, Loddon, Bendigo, Maryborough, Avoca and Tarrangower. He was in business when the township of Sandhurst was first opened, with hisformerschool teacher, the well-known author, B. L. Farjeon. Growing tired of life on the diggings in 1856, Mr. Cohen came back to Ade-laide, where he passed the rest of his life. He was best known in connection with buildings in the city, and during his long residence here he had expended over £50,000 in here he had expended over 205,000 h buildings and improvements within the municipal boundaries. Thirty-two years ago he pulled down three shops opposite the Globe Hotel in Rundie-street and rebuilt them. He built the Monster Clothing three-storied building at the corner of King William and Hindley-streets, converted two shops into the Inter-national Hotel in Rundle-street, and built the warehouse occupied by Messrs. McLean Bros. and Rigg in Hindley-street. Among his latest efforts in this line was the transformation of the old Commercial Bank into the suite of offices now known as Comstock Chambers, and securing the lease of Messrs. R. H. Wigg & Co.'s premises in King William-street he converted the building into two shops, one of which is now occupied by Taylor's original promoters in the building of the Adelaide Arcade, and he was sent to London by his co-directors to purchase the whole of the glass, the marble tilings for the floor, and the electric lighting plant. In 1858 the deceased gentleman married Miss Benjamin, sister

of Mr. P. Benjamin, who was subeditor of the *Register*. He leaves eleven children, five daughters and six sons. One daughter is married to Mr. L. Moss, the others being Misses S. R. L. and E. Cohen. The eldest son, Mr. B. E. Cohen, is manager of the jewellery department of Messrs, P. Falk & Co.; the next, Mr. M. Cohen, is in the Architect-in-Chief's office, Ferth; whilst the third, Mr. S. E. Cohen, manages the jewellery department of Messrs. Hoffnung & Co., Sydney. The other three sons are Messrs. P., L., and F. Cohen. Mr. Cohen, who was in business for nine years at Goolwa, was attacked by pleurisy some little time back, and on top of this came cancer. During his illness Mr. Cohen, who was 60 years of age, was attended by Dr. J. C. Verco. The funeral takes place at 3 o'clock to-day.




News of the Week,

10 August 1878 [South Australian Chronicle and Weekly Mail, 10 August 1878]

The tender of Mr. J. Jude, amounting to £8,894, for the erection of four shops and dwelling houses in Rundle-street east for the South Australian Company has been accepted, and the work will be commenced immediately. The premises included in the contract comprise basement, ground, first and second floors, and occupy a frontage of 86 feet, and are to form ultimately a portion of an extensive range of buildings, extending from Bent-street on the east side to the premises lately crected by Mr. Hornabrook on the west side-a total frontage of 300 feet. The elevations are designed in the Italian style, and will be executed with coursed freestone and cement dressings. The work throughout is to be of the most substantial character. Mr. W. McMinn is the architect.

COHEN'S FAMILY HOTEL.

Last year the Royal Commission which sat to enquire into the state of the liquor laws reported, amongst other things, that the testimony brought before them cenerally was that there was a great want of really first-class hotel accommodation for families and visitors to the city. Such accommodation Mr. E. Cohen seeks to afford in the hotel in Rupdle-street east for which he has applied for a licence, and there is no doubt that the premises are both comfortable and convenient in a very marked degree. The rooms, of which there are about forty, are unusually lofty. spacious, and well ventilated, and they have been furnished throughout with the most complete regard to detail and even elegance. The height of the spartments on the ground floor is sixteen feet, and the second storey fifteen feet, and on the third fourteen feet. There are a large dining-room, hung with mirrors and oil · psintings ; private sitting-rooms, a smoking-room, and, what is far more exceptional in these colonies, a handsomely appointed drawing-room twenty feet square for the general use of the lodgers. But the great feature in the house are unquestionably the bedrooms. These are exceptionally large and well lighted, each having a patent ventilator in the sill of the window, so that a current of fresh air flows into the spartment when the window is closed. The rooms are uniformly fitted-up with Huonpine and marble furniture, French porcelain toilet services, and other conveniences-even to engravings for the adornment of the walls. There are double staircases and separate bathrooms for ladies and gentlemen. The cellar accommodation extends under the whole of the premises, which are very cool. About a dozen representative gentlemen visited the house on Tuesday at the invitation of Mr. Ochen. and.

having inspected the various rooms, generally pronounced the accommodation to be first-class. After they had partaken of an elaborate luncheon, Mr. W. Townsend, M.P., in proposing success to Mr. Cohen, said there could be but one opinion—that the house supplied a muchneeded want, and was such a one as ought to receive a licence, affording as it did, in no figurative sense, the comforts of home. Mr. Cohen, in responding, said he had recognised the want which had been referred to, and had endeavoured to the best of his ability to supply it. EMANUEL COHEN V. G. SHARP. - Olaim for £2 12s., balance due for board and lodging. Mr. Bray defended. Plaintiff was the landlord of Cohen's Family Hotel in Rundle-street, and the defendant was Mr. Granville Sharp, who has lately been lecturing in Adelaide on the Chinese at home and abroad. According to the plaintiff's evidence the defendant engaged rooms for himself and wife for one week with the option of remaining longer, the terms sureed on being the same as were printed on the hotel cards, viz., two guineas each per week, and for every additional day over the week Ss. each per day. When they were coming to terms the defendant said it was very unfair to charge 8s per day, as it was altogether out of proportion to the rate of two guineas per week. He came on the Thursday afternoon, and left on the Saturday afternoon. Mrs. Sharp did not come till within a few minutes of his leaving. When the bill was presented Mr. Sharp disputed the charge of four guineas for one week's board and lodging for himself and Mrs. Sharp, and refused to pay more than 32s., being at the rate of Ss. each per day for two days. The defendant denied that he took the rooms for a week, and said he could not have done so, as his movements were very uncertain at that time. He contended that he had already paid far more than the plaintiff was entitled to. because Mrs. Sharp was never in the hotel, and there was no understanding that he was to pay for two persons if she did not come. The S.M. said that the evidence for the plaintiff preponderated, and he must give a verdict for the amount claimed. Verdict for plaintill accordingly.


THE ADELAIDE ARCADE.

On Wednesday afternoon the foundation stone of the new Arcade to be erected between Randle and Grenfell streets, was laid by the Mayor (Mr. W. Bundey, J.P.) in the presence of a large crowd of people. His Worship and fourteen members of the City Council arrived at the spot just prior to 3 o'clock, and the ceremony was performed at that hour. The locality of the stone is the corner next to the abop of Mearrs, Smith and Parker, and the stone itself was a narrow marble block containing the following inscription-"Adelaide Arcade. This stone was laid by His Worship the Mayor (W. Bundey, Esq., J.P.) the 6th day of May, 1885. W. Pett & Sons, contractors; Withall and Wells, architects." Mr. Solomon presented. His Worship with a silver trowel with which to perform the ceremony. Mr. BUNDEY said it afforded him very much pleasure to lay the stone of the first Arcade erected in Adelaide. Nothing would give him greater delight than to see the city prosper, though it was true that at present great depression existed. Similar distress had, however, arisen in years gone by, and he only hoped that better times would soon prevail through the length and breadth of the land. He looked upon this undertaking as one which would be a benefit in the future as well as at present, and his best wish was that prosperity might crown the efforts of the promoters in their work. His WORSHIP then called for three cheers for the Company, after which, at Mr. Solomon's suggestion, the crowd cheered the Mayor. Under the stone was placed a bottle containing copies of the daily papers, and a document, including, among other information, the following :-"Adelaide Arcade Company, Limited. Shareholders - Saul Solomon, Joachim Matthies Wendt, Lewis Heary Berens, Patrick Gay, Robert Carr Castle, Hermann Carl Koeppen Wendt, Emanuel Cohen.

Directors- Sau' Solomon (Chaifman), J. M. Wendt, E. Cohen, P. Gay, and L. H. Berens. Secretary, Gavin Forest Gardner ; solicitors, Symon, Bakewell, & Symon ; architects, Withall & Welis ; contractors, W. Pett and Sons. May 6, 1885." An adjournment was then made to the King of Hanover Hotel, where several toasts were drunk. Mr. SOLOMON, in proposing the Mayor's health, expressed the hope that he had not only laid the foundation stone of this building, but that he had also initiated a season of renewed prosperity in the colony. The promoters had sufficient confidence in the undertaking, and felt satisfied that it would be a commercial success in every way. The MAYOR, in regrand future for the colony, and that what was now being done would be for the benefit of their children. Adelaide had of late years been very much improved by buildings, and visitors from other parts to the city frequently expressed their surprise on seeing it so much advanced. They were delighted to find men among them who were willing to expend their capital for the benefit of the citizens, and no one would laugch into a venture of this description without having fully weighed the future. He trusted that the result would be far beyond the promoters' anticipations. His Wonsmir then proposed' the toast of "The Company," to which Mr. SOLOMON responded, mentioning that the promoters had carefully considered the question. Their scheme was not of mushroom. growth, or even the result of two or three months' study, as several of the gentlemen interested had been considering the matter for years past, but it had required three fires to enable them to secure the present site. The Com-pany was perfectly prepared to maintain any risk which might attend the affair, but he thought they deserved a pat on the back for undertaking such

an extensive scheme during these depressed times. The heavy rents demanded for small business places was one of the principal objects which induced them to devise a scheme which would meet that difficulty. and he was convinced the venture would return something tangible to its promoters. Mr. G. D. GEREN proposed "The Architects," remarking that the building would be a credit not only to Adelaide and the Com-pany, but to Mesers. Withall & Wells, who pany, but to Memora, Withall & Wells, who had so very skilfully prepared the plans. Mr. WITHALL responded. Mr. E. T. SWITH, M. P., followed with the toast of "The Builders." During his speech Mr. Smith mid that he trusted that the objectionable assessment now enforced would soon be abolished, and that one dealing with the land only substituted. The assessment was at present made on the property, and as an instance of the unfairness of such a course he referred to the shops lately crected in Rundle-street east by the South Australian Company and Mr. Martin, half of which are still vacant. Speaking of the builders of the Arcade, Mr. Smith mid that the Company had secured the services of a competent firm, and with the architects there was little doubt that the building would be a substantial and creditable edifice. Mr. W. PETT acknowledged the toast, and stated that though the ledged the toast, and stated that though the specified time for completing the contract was short he had no doubt that the building would be needy to hand over to the promoters when the data arrived. The toast of "The Corporation was given by Mr. BUIK, and responded to be Aldermen KITHER and Fox, and that of "The Corporation Officers" followed before the company, numbering about 50, distances.

A meeting of the creditors of Mr. Emanuel Cohen, of Adelaide, merchant, was held at the office of Messra. W. & T. Pope, King William street, Adelaide, on Friday, August 10, Mr. A. W. Meets in the chair. The balance-sheet showed—Lisbilities. £11,127; contingent, £22,000; total, £33,127. Assets, £13,344; contingent, £22,000; total, £35,344; estimated surplus, £2,216. It was resolved that the estate should be assigned to Messra. A. W. Meeks (Gibbs, Bright, & Co.), and F. H. Wigg (R. H. Wigg & Son), and that the calling of the meeting should not be deemed an act of insolvency.
